We were furnished copies of deferrals which the President submitted to the Congress on March 18, 1976, in his 12th special message for fiscal year 1976 pursuant to the Impoundment Control Act of 1974. The special message transmits six new deferrals and one revised deferral. The President estimates that the impoundments will reduce fiscal year 1976 outlays by \$61 million in the Department of Agriculture.

The Impoundment Control Act requires us to review each message and report promptly to the House and Senate as to the facts surrounding each action, including the probable effect thereof and, in the case of deferrals, to render a judgment as to whether the action is in accordance with existing legal authority. We are also required to notify the Congress if supplementary information revising earlier messages necessitates changes in the original reports submitted by GAO. Our comments on each impoundment transmitted by the President's 12th special message are enclosed.

COMMENTS ON THE 12TH FY 1976 SPECIAL MESSAGE

The information provided in the above message is essentially correct and the actions being taken are reasonably clear. The message, however, is not complete and therefore could be misleading. According to available information, these funds are the subject of a pending legal suit which we feel Congress should have been made aware.

Agency records disclose that the Department of Agriculture proposed to defer these funds on Feburary 6, 40 days before they were reported by the President. This delay in reporting the deferral causes an extension of time before the deferral could be considered for possible rejection by either House of the Congress. OMB concurred in that deferral on March 1. The deferral is authorized by the Impoundment Control Act. The authority exists until either House of the Congress passes a resolution disapproving the action or until the end of the fiscal year.

The information provided in the above messages is essentially correct and the actions being taken are reasonably clear. For D76-104, the funds have already been released as reported in our letter to the Congress dated March 22, 1976, (see rescission R76-16).

Deferrals D76-106, D76-107, and D76-108 are in accordance with the authority conferred by the Anti-deficiency Act (31 U.S.C. 665). Deferrals D76-104 and

D76-109 are authorized by the Impoundment Control Act.

The authority exists until either House of the Congress passes a resolution disapproving the action or until the end of the fiscal year.

The President's supplementary information generally increases the amount of budget authority being proposed for impoundment. The revised message does not require us to modify our earlier report to the Congress which commented on the original message.
