

On June 25, 1993, we provided you with certain information on the top 500 Bureau of Land Management (BLM) and top 500 Forest Service grazing permits, as measured by the allowable level of livestock grazing (GAO/RCED-93-190R). At that time, we agreed with your offices to obtain missing addresses and phone numbers of permit holders. This letter and its enclosures supplement our June 25th letter. There are two instances in which phone numbers and/or addresses could not be obtained. In one, the permit holder had an unlisted phone number (indicated by "N/A" or "not available"); in the other, the permit was canceled, sold, or transferred (indicated by "CST").
