Subject: Comparison of Voting Age Population to Registered Voters in the 40 Largest U.S. Counties

Earlier this month, you introduced S. 528, the “Safeguard the Vote Act.” Section 3 of that legislation would require states and localities to purge voter rolls if they discover that the number of registered voters exceeds the number of eligible voting age residents. You asked us to compare data on the number of registered voters for the largest counties in the United States with estimates of voting age populations for those jurisdictions.

The enclosed table provides the data for the 40 largest counties. As you will see, none of the counties have voter registration numbers that exceed the number of eligible voting age residents.

To determine the largest U.S. counties and their voting age populations, we used 1998 population estimates from the Census Bureau—based on the 1990 census—to estimate voting age populations (“1990 to 1999 Annual Time Series of County Population Estimates by Selected Age Groups”). To estimate voting age population, we subtracted the estimate of population 17 years and younger from the total population estimate for each county. We obtained the number of registered voters for these counties from Election Data Services (EDS), a political consulting firm specializing in election administration and the analysis and presentation of census and political data. EDS obtained these data directly from the counties. For Milwaukee County, EDS did not have data, so we obtained the number of registered voters from the Wisconsin State Board of Elections. The latest comparable data sets are for 1998; although the Census Bureau has population data based on the 2000 census, EDS had not made its data on the numbers of registered voters for the 2000 election available when we did this analysis.
