To the President of the Senate and the
Speaker of the House of Representatives

On January 12, 1984, the President's fifth special message for fiscal year 1984 was submitted to the Congress pursuant to the Impoundment Control Act of 1974. The special message proposes seven new deferrals totalling \$1,832,465,000 and revisions to seven previously reported deferrals totalling \$2,734,156,870. Our report follows.


