Subject: Family Planning: Federal Funds Provided to Planned Parenthood Organizations

This letter responds to your request that we identify for the Planned Parenthood Federation of America, the International Planned Parenthood Federation, and the Alan Guttmacher Institute (1) the amount of federal funding that supports these organizations, (2) federal agencies that receive and disburse the funds, and (3) congressional committees with jurisdiction to authorize or appropriate these funds.

In summary, we found that the Planned Parenthood Federation of America and its affiliates, the International Planned Parenthood Federation and its associations, and the Alan Guttmacher Institute received federal government support that ranged approximately \$158 million to \$163 million annually during fiscal years 1994 through 1996. (See table 1.) The Department of Health and Human Services (HHS) and the Agency for International Development (AID) were the major sources of these federal funds.

Four committees in the Senate and three committees in the House of Representatives hold jurisdiction over the authorization of these activities, and three subcommittees of the Committee on Appropriations of each house hold jurisdiction over appropriations of these funds.¹

This correspondence is based on data collected from and discussions with officials from HHS, the Department of Commerce, AID, Planned Parenthood Federation of America, International Planned Parenthood Federation, and the Alan Guttmacher Institute. As we indicated to your staff, we did not independently verify financial data provided by federal agencies and Planned Parenthood organizations; however, Planned Parenthood organizations provided independently audited financial statements and reports. We carried out our work between March and May 1998 in accordance with generally accepted government auditing standards.

BACKGROUND

The Planned Parenthood Federation of America and its 137 affiliates, with 900 local health centers, provide reproductive medical care, emphasizing family planning counseling and birth control education. Planned Parenthood Federation of America affiliates are independent, separately incorporated organizations with their own boards of directors and financial autonomy. In 1996, Planned Parenthood affiliates provided reproductive health care to 3.3 million women and men and educational services to an additional 1.6 million individuals. Affiliates and their clinics provide family planning counseling and birth control services, pregnancy testing, abortions, cancer screening, HIV testing, screening and treatment for sexually transmitted diseases, prenatal and well-baby care, and other reproductive health care services.

The International Planned Parenthood Federation is a nonprofit, nongovernmental family health care organization, headquartered in London and registered as a charity in the United Kingdom. The International Planned Parenthood Federation has six regional offices and 127 affiliated family planning associations and operates in 160 countries. These organizations provide family planning and reproductive health services, including maternal care and screening and treatment for sexually transmitted infections. The International Planned Parenthood Federation is supported by financial contributions from more than 25 governments and by donations from private foundations and individuals.

The Alan Guttmacher Institute was originally a division of the Planned Parenthood Federation of America and became an independent not-for-profit corporation in 1977; it remains a special affiliate of the Planned Parenthood Federation of America. The Alan Guttmacher Institute conducts reproductive health and family planning research, policy analysis, and public education nationally and internationally and publishes journals about family planning and reproductive health.

FEDERAL FUNDS FOR DOMESTIC ACTIVITY OF PLANNED PARENTHOOD ORGANIZATIONS

During fiscal years 1994 through 1996, federal programs provided approximately \$120 million to \$123 million annually in grants and reimbursements for domestic activities to the Planned Parenthood Federation of America and its affiliates and to the Alan Guttmacher Institute. (See table 2.) HHS provided almost all of this funding, primarily through grants to states, which, in turn, disbursed the funds to these Planned Parenthood affiliates.

Title X of the Public Health Service Act authorizes grants for voluntary family planning services, primarily for low-income women. In fiscal year 1996, title X grants accounted for 38 percent of all domestic federal grants and reimbursements to the Planned Parenthood Federation of America and its affiliates and the Alan Guttmacher Institute. Title X also provides funding for training nurse practitioners and for health services research about family planning services.² Title X grantees include state and territorial health departments, local health departments, hospitals, and organizations such as Planned Parenthood affiliates. Grantees can dispense title X funds to other agencies to provide services or to support clinics. Although there are no matching requirements for grants, regulations specify that no clinic may be fully supported by title X funds. Federal law also prohibits the use of title X funds in programs where abortion is a method of family planning.

²During fiscal years 1994 through 1996, the Planned Parenthood Federation of America and an affiliate received such training grants, ranging in total from \$660,000 to \$694,070 annually. During the same years, the Alan Guttmacher Institute received a research grant ranging from \$460,000 to \$521,720 annually.

Title XIX of the Social Security Act authorizes Medicaid grants to the states and requires state Medicaid programs to cover family planning services. The Health Care Financing Administration (HCFA) pays 90 percent and states pay 10 percent of Medicaid's reimbursements for family planning services and supplies. This payment formula applies only to family planning services and supplies, defined as services intended to increase or decrease family size. Any other covered Medicaid service provided by Planned Parenthood centers, including abortion when permitted under law, is reimbursed under standard federal-state payment formulas.³ HCFA's most recently published state data show that in fiscal year 1996, Medicaid reimbursed \$500 million (0.4 percent of Medicaid payments for claims) to private physicians, nurse practitioners, migrant and community health centers, public health clinics, and hospital clinics for family planning services. States do not report services provided by Planned Parenthood affiliates separately from other providers.

Title V and title XX of the Social Security Act authorize the Maternal and Child Health Services Block Grant (MCHBG) and the Social Services Block Grant (SSBG). MCHBG and SSBG funds are distributed by formula to state and territorial health and social service agencies; federal MCHBG funds are matched by state funds. Each state determines the use of the combined funds and its federal SSBG funds. Under either block grant, state agencies may fund family planning activities directly or purchase them from Planned Parenthood affiliates or others. The most recent SSBG data show that in fiscal year 1995, states used \$32.7 million—1.1 percent—of state SSBG funds for family planning services.

Title IV and section 301 of the Public Health Service Act authorize the National Institutes of Health to award research project grants. Between fiscal years 1994 and 1996, the National Institute for Child Health and Human Development's Center for Population Research, Demographic, and Behavioral Science Branch awarded two research project grants to the Alan Guttmacher Institute to study contraceptive effectiveness and women's prenatal behaviors.

Under section 392 of the Communications Act of 1934, which authorizes the Telecommunications and Information Infrastructure Assistance Program in the Department of Commerce, the National Telecommunications and Information Administration through its Office of Telecommunications and Information Applications awarded in 1994 a matching grant to the Planned Parenthood Federation of America for developing a computerized information system for collecting and exchanging data on reproductive health care.

³Except for family planning services and services provided through Indian Health Service facilities, the federal portion of payments for Medicaid services is set annually for each state by a formula and may range from 50 to 83 percent.

FEDERAL FUNDS FOR INTERNATIONAL ACTIVITY OF PLANNED PARENTHOOD ORGANIZATIONS

For fiscal years 1994 through 1996, the International Planned Parenthood Federation and its regions and affiliated family planning associations and the Alan Guttmacher Institute received annual financial support for international activities from AID totaling approximately from \$36 million to \$43 million. (See table 3.)



AID provides assistance through direct grants and other mechanisms, such as cooperative agreements. A cooperative agreement is a grant under which substantial involvement is anticipated between AID and the recipient—called a cooperating agency—during performance of a funded activity. AID missions fund some International Planned Parenthood family planning associations directly. AID's cooperating agencies may also support some International Planned Parenthood family planning associations through subgrants.

AID grants to the International Planned Parenthood Federation are used to introduce, expand, and improve family planning and reproductive health information and services through its affiliated network of indigenous family planning associations. AID's cooperative agreement with the International Planned Parenthood Federation's Western Hemisphere region was used to improve and expand family planning services in Latin America and the Caribbean and to incorporate AIDS and other sexually transmitted infection prevention services into family planning programs. In addition, two AID missions had a contract and a grant directly with Family Planning International Assistance, the international service division of Planned Parenthood Federation of America, to supply contraceptive commodities to Nigeria and to initiate a family planning and birth spacing program in Cambodia.

The Alan Guttmacher Institute receives, through a subagreement, funding from AID for publishing an international journal in English, French, and Spanish about family planning and reproductive health issues.

Officials from AID, Planned Parenthood Federation of America, and the Alan Guttmacher Institute reviewed this correspondence, generally agreed with the information contained in it, and provided technical comments, which we incorporated where appropriate.
