To the President of the Senate and the Speaker of the House of Representatives

On June 2, 1982, the President's thirteenth special message for fiscal year 1982 was transmitted to the Congress pursuant to the Impoundment Control Act of 1974. The special message proposes seven new deferrals totalling \$14.5 million and revisions to two deferrals previously reported increasing the amount deferred by \$140.5 million. Our report follows:

The special message states that these funds are being deferred pending Congressional action on a proposal to transfer the funds to the salaries and expenses account to meet increased pay costs. The conference version of H.R. 5922, the 1982 urgent supplemental appropriations bill, provides a supplemental amount of \$3.5 million for salaries and expenses, instead of the \$2.8 million requested by the Executive. The bill also specifies that the funds will be derived by transfer from the Economic Development Revolving Fund, rather than the EDA program account which is the subject of D82-245.

EDA officials told us that in light of Congressional action on H.R. 5922, they have requested that the deferred funds be released. Program officials also said that they will propose that the \$2.8 million be reprogrammed into the Title IX economic adjustment grant program. Consideration by the Commerce Department of the EDA request, dated June 14, 1982, will take approximately 30 days. If approved by the Department, the request then will be submitted to OMB for its approval.

Agency officials told us that the \$400,000 deferral is comprised of \$200,000 for acquisition management, used for planning future land acquisitions, and \$200,000 from the current land acquisition program for the Bon Secour Wildlife Refuge, Alabama, for which the total estimated land acquisition cost is \$3,360,000.

D82-229A Employment and Training Administration Employment and Training Assistance 161/20174 1620174

This deferral message reports an increase of \$140,554,000 to the deferral reported in D82-229. The increased amount represents a withholding of funds for the Job Corps program pending OMB approval of the Department of Labor's fourth quarter operational plan for the Job Corps. According to agency budget officials the deferral is comprised of the following amounts:

In April 1982, the agency requested release of the \$47.4 million whose disposition was under review, for training and related assistance for displaced workers and for CETA audits. The request was denied by OMB in early May 1982. At that time, OMB also withheld approval for the agency's fourth quarter operational plan for the Job Corps because it did not indicate how the agency planned to reduce enrollment by the end of fiscal year 1982, in keeping with the transition to a smaller Job Corps program proposed in the fiscal year 1983 budget.

Agency officials expect OMB approval of the revised Job Corps plan before the start of the fourth quarter. However, if the plan is not approved and funds released by then, the officials said that there may be adverse effects on Job Corps centers and enrollments.
