The President's fourth special message for Fiscal Year 1978 was transmitted to Congress pursuant to the Impoundment Control Act of 1974. Findings/Conclusions: The message includes four new deferral proposals: International Security Assistance Military Assistance, International Military Education and Training, and Foreign Military Credit Sales, all from funds appropriated to the President; and Antirecession Financial Assistance Funds appropriated to the Department of the Treasury. Revisions are transmitted to four previously transmitted deferrals: Emergency Refugee and Migration Assistance Funds appropriated to the President, and three funds appropriated to the Office of the Secretary of the Treasury. The information provided in the fourth special message is correct, and the actions being proposed have been clearly and accurately stated.

On December 15, 1977, we received copies of the President's fourth special message for fiscal year 1978 that was transmitted to the Congress pursuant to the Impoundment Control Act of 1974.


