The Comptroller General is required, by law, to develop standard terms and classifications for Federal fiscal, budgetary, and programrelated information; to identify congressional needs for such information; and to monitor recurring reporting requirements of the Congress and recommend changes. This annual report, required by title VIII of the Congressional Budget Act of 1974, lists GAO's work in these areas over the past year.

To the President of the Senate and the Speaker of the House of Representatives

This report is submitted to the Congress in accordance with section 202(e) of the Legislative Reorganization Act of 1970, as amended by title VIII of the Congressional Budget Act of 1974. This section requires us to report annually on the progress and results of our continuing program, undertaken in accordance with the 1970 act, as amended, to improve the fiscal, budgetary, and program-related information reported to the Congress.

We have studied and reported on many aspects of the budget process during the past year. We have provided numerous reports to the Congress, testimony before congressional committees, and other assistance to members and staff of the Congress. These reports and actions are listed in the enclosures to this letter. Enclosure I lists the 43 budgetrelated reports we issued and Enclosure II lists the 13 occasions we testified since September 1, 1979.

These reports include analyses and recommendations for improving agencies' budget execution, including improvements in monitoring and controlling spending patterns to avoid wasteful year-end obligations and expenditures. The reports also address needed improvements in budget formulation and information in reports concerning zero-base budgeting; case studies of budget development in the Departments of Defense, Interior, and Health, Education, and Welfare; the feasibility of a "mission" budget structure for the Department of Agriculture; and the use of "full funding" practices for multi-year projects and activities.

Our reports and testimony also analyze various proposals for improving congressional oversight and executive branch accountability ("sunset" legislation, etc.). Other matters covered include needed improvements in the budget treatment of agency borrowings, ways to enhance congressional control over Federal credit activities and research and development programs, and the elimination of unneeded reporting by agencies to the Congress.

Moreover, we continued our cooperative work with agencies to provide program and budgetary information to several congressional authorizing committees for use in their March "views and estimates" reports to the Budget Committees. Assistance was provided to 21 committees requiring close work with over 80 agencies and commissions.

GAO NOW PREPARING A COMPREHENSIVE REPORT ON CURRENT ISSUES IN THE BUDGET PROCESS

Ten years have elapsed since enactment of the Legislative Reorganization Act of 1970. During that decade there has been a rapid growth in the variety and complexity of Federal programs--e.g., loan guarantees became an important form of Government assistance--as well as important institutional changes in budget processes. The enhanced role of the Congress in the budget process has been the most significant institutional change.

This period of rapid change has produced new budget issues not addressed by the President's 1967 Commission on Budget Concepts, and frequently divergent responses from the organizations involved in budget matters. We therefore felt a need to initiate a comprehensive study this year to summarize the major issues related to the budget process and budgetary information.

The study is addressing such subjects as:

- --budget coverage, including the problem of "off-budget" activities;
- --the categories and entities that should be the focus of congressional and executive branch budgetary actions--e.g., "national needs," "missions," programs, accounts, etc.;
- --measurement and estimating problems, covering the need for more consistent recordings of budgetary amounts, the need for more realistic budget projections, and related issues;
- --the adequacy of reporting on budget assumptions, global and national conditions and trends, and cross-cutting policy areas;
- --budget controllability, including procedures to limit entitlements, and the usefulness of the existing "relatively controllable"/"relatively uncontrollable" framework;
