

**To the President of the Senate and the

On September 8, 1995, the President submitted to the Congress his sixth special impoundment message for fiscal year 1995. The message reports one revised deferral of budget authority. We have reviewed the deferral and found it to be in accordance with the Impoundment Control Act, 2 U.S.C. § 681, et seq., as amended.

Enclosure I provides specific information with regard to the deferral which we believe will be useful to the Congress in its examination of the message. Enclosure II lists the deferral as reported by the President.

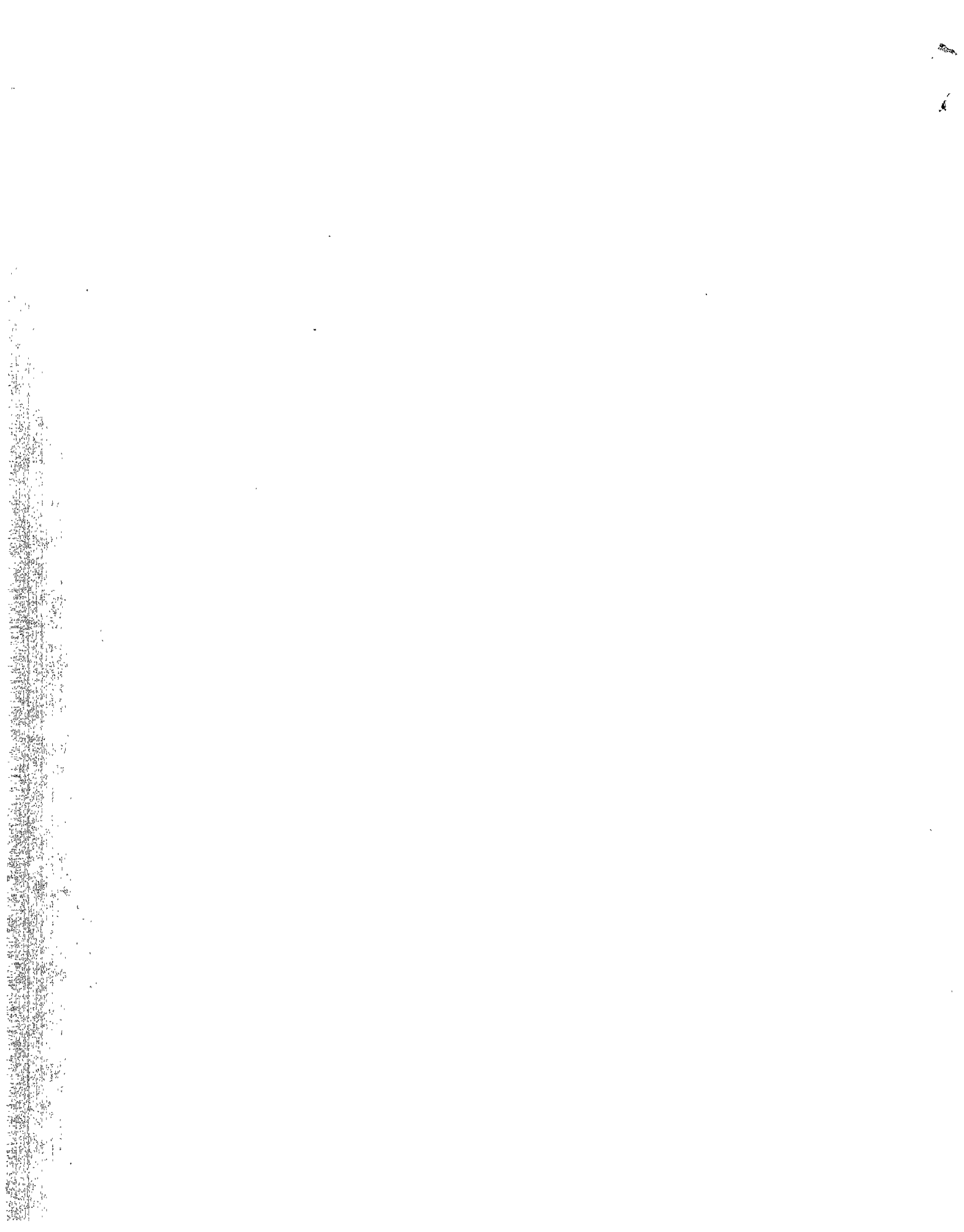

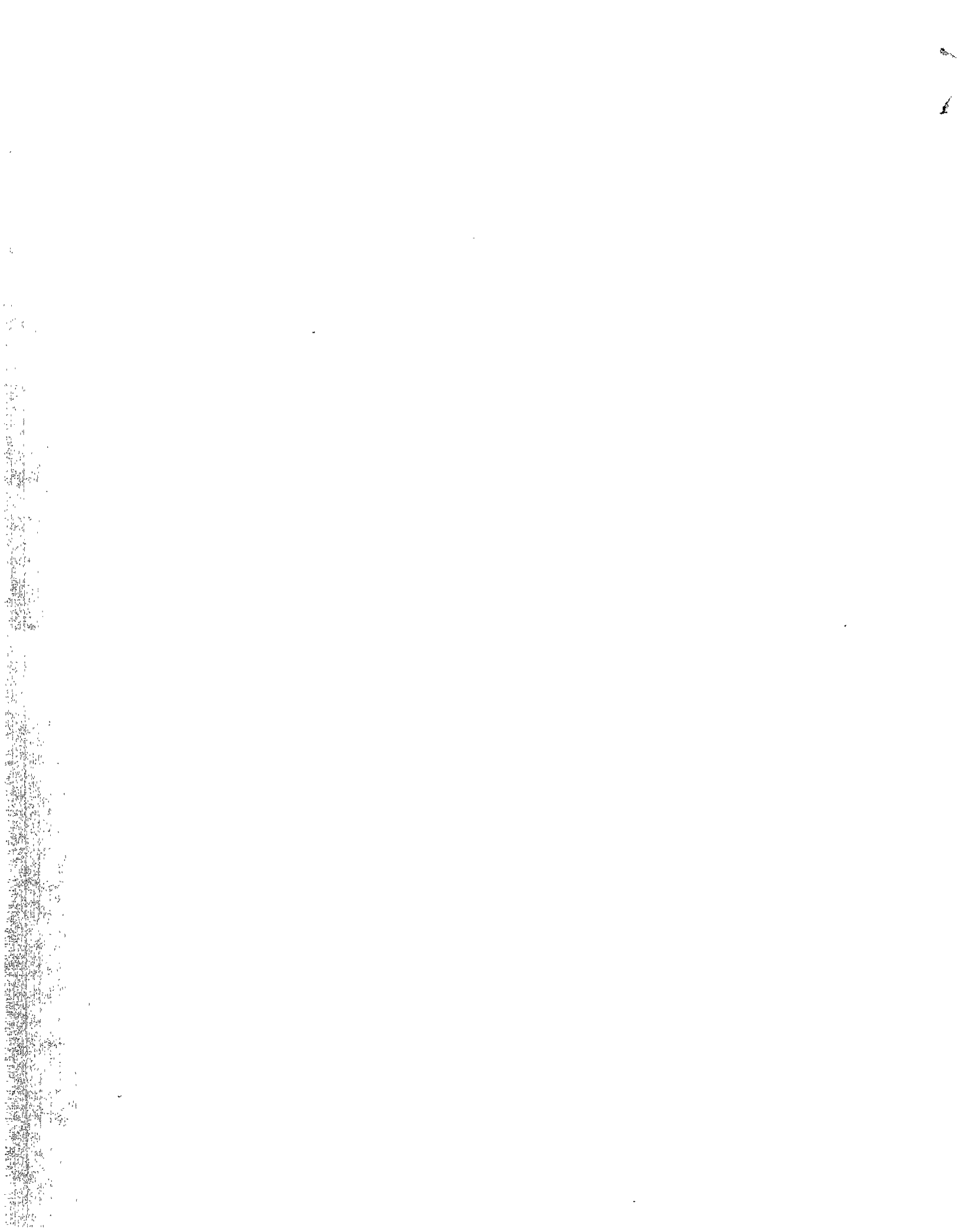

This deferral increases by \$18,808,000 the total of the previous deferral in the Economic Support Fund. According to the most recent cumulative report, submitted to the Congress on September 14, 1995, the total amount currently deferred has been reduced to \$300,757,000 due to subsequent releases of budget authority.
