

To the President of the Senate and the
Speaker of the House of Representatives

On November 19, 1993, the President submitted to the Congress his third special impoundment message for fiscal year 1994. The message reports four deferrals of budget authority and revises the amounts of two deferrals previously reported. We have reviewed these deferrals and found them to be in accordance with the Impoundment Control Act, 2 U.S.C. § 681, et seq., as amended.

Enclosure I provides specific information with regard to three of the deferrals which we believe will be useful to the Congress in its examination of the message. Enclosure II provides a list of the deferrals as reported by the President.

OMB's Cumulative Report, submitted to the Congress on December 9, 1993, also shows the total amount currently deferred as \$1,474,380,000 and not \$1,558,737,203 as reported in the message.
